Teaching Topics for Series 1:

1. Introduction: Does Money Really Affect My Relationship With God?

It is vital for Christians to know and understand the importance of handling money in accordance to Biblical teachings as it affects our relationship with God. Applying practical, biblical principles about money can transform our finances and would result in us living a life as a true worshipper as Paul had taught in Romans 12:1-2. Learning and applying God's truth will transform every area of our lives towards God and in this seminar, we are targeting on the subject of money and possessions.

2. Ownership: Who Really Is The True Owner?

How we view God determines how we live! When we acknowledge God as our Lord, how His Lordship is in how we handle money on a daily basis. Is it my decisions of how I used my own money or is it a spiritual decision? Am I a faithful steward? How would the teaching of Paul in 2 Corinthians 5:10 apply to us when the day of accounting comes and how prepared are we to give our Lord an accounting of what He had given to us to steward in this brief life.

3. Debt: It Can Lift You Or Crush You!

The secular teaching of using other people's money to make more money has been widely applied in the business world. Do we know the dangers and trappings of being in debts? In our debt counselling, where we help seekers who have debt problems with Licensed Money Lenders and Unlicensed Money Lenders, some had tried to commit suicide because they could not take the pressures and anxieties mounted on them by their debt and debtors. What does the Bible teach and how applicable and relevant are these teachings in the 21st Century? In a practical way, we can learn how to make sound and Biblical judgments regarding taking on debts.

4. Godly Counsel: Who Should I Listen To?

On a weekly basis, when we counsel people with financial problems, It is often the case that they could have avoided their challenges and difficulties if only they had sought counsel from someone who had a solid understanding of God's way to handle money. What holds us back from seeking counsel? Let's find out and avoid the pitfalls of not seeking counsel.

5. Integrity: What Is So Good About It?

Why is it important to make daily decisions to handle money honestly? How does it affect our spiritual life in Christ? What does the Manual for Life have to teach us? There are plenty of Biblical truths that would lighten our burdens and stress if we could learn to handle money and possessions according to God's way since He knows what we are made of.

6. Giving: More Blessed To Give or Receive?

Jesus said it is more blessed to give than to receive. Isn't it better to keep than to give? What are the attitudes we need to have in giving? What are the advantage of doing so? Where do we give? These issues would be addressed from a Biblical perspectives.

What are the warnings and teachings given by God since in the Bible, there are many rich people too? Learning these Biblical principles will lead us in the paths of riches and righteousness.

3. Contentment: Living With Much or Little?

The Bible does not prescribe one standard of living for everyone. It has teachings on all issues of life like lifestyle, prosperity, taxes and teaching children about money.

God places His people in every level of society to do His will and He has made us His ambassadors. The rich and the poor believers, like the examples in the Bible, have His light shining from within us to be His witnesses. When we live according to the Biblical teachings, we are showing the world how to live well and successfully because we have God in our midst and prayerfully they too would embrace the Mighty God.

4. Eternity: Store Up Treasures In Heaven!

One of the most critical teachings for Christians to understand when handling money is the reality of eternity. We know God loves us and He reveals through His word that there is a heaven and a hell, there's a judgment coming, and He will grant eternal rewards. He wants to tell us to sow our lives and finances in such a way that we can enjoy an intimate relationship with Him now and receive the greatest possible rewards and responsibilities in His eternal Kingdom when Christ returns. We most desire to learn more and look at practical ways of sowing into God's Kingdom.

During this course, we will learn practical ways of handling money & possessions such as Financial Statement of Assets and Liabilities, budgeting, creating spending plans, creating wills, and etc.
