Mental Health and the Church: According to the mental health survey of 607 Singaporeans conducted by Young PAP (for #BetterTogether) in 2022, 2 in 5 people have personally experienced mental health struggles. Another survey in the same year that formed part of the Singapore Youth Epidemiology and Resilience Study involving 3,336 young people aged 11 to 18 revealed that 1 in 3 youth in Singapore has reported internalising mental health symptoms such as sadness, anxiety and loneliness. The church is also not spared the onslaught of mental health struggles that our nation has had to face.

This is why Ethos Institute for Public Christianity has decided for our ETHOS Conversation 2023 to address this pertinent topic of "Mental Health and the Church". Join us as we bring into conversation Senior Consultant Psychiatrist Dr Adrian Loh and the President of Koinonia Inclusion Network Mr Leow Wen Pin to offer medical, psychological and theological perspectives on mental health. BCA (Building and Construction Authority) would like to remind churches that in March 2020, the Building Control Act has been amended, whereby owners of existing non-barrier-free buildings may be required to provide at least basic accessibility features for Persons with Disabilities ("basic accessibility requirement"), if owners carry out addition and alteration ("A&A") works requiring plan approval in any part of the non-barrier-free buildings.
