Some of the priorities of the Exco are to facilitate good working relationships among churches, and also to represent the Christian community responsibly in the public square. NCCS 50th Anniversary: Singapore churches, especially the traditional denominations and some older churches were part of the Malayan Christian Council (1948), and the Council of Churches of Malaysia and Singapore (1963). These church councils played special roles during an era when Singapore was not yet an independent nation.

After 9 August 1965, it was deemed appropriate for churches of our sovereign nation to form its own National Council of Churches of Singapore, which was registered on 24 July 1974. Since then, NCCS has been representing Christians in Singapore in the public square, addressing many concerns that are unique to our church and society. Our journey together has had its challenges as well as achievements and it is with gratitude to God that NCCS will celebrate its 50th Anniversary on 24 July 2024. Every member church and organisation will be represented at the dinner celebrations. Planning is underway and we will share more details in due course.

Registry of Marriages: NCCS continues to serve all churches in Singapore that require its recommendation to the Registry of Marriages (ROM). As partners with ROM, we assist churches applying for the Licence to Solemnise Marriages (LSM), and the renewal of existing Licences. We would like to share the following information with churches.

- It is normally a one-year cycle from application to approval.
- For a new LSM application, please submit the complete set of documents to NCCS for endorsement by the end of the calendar year.
- For renewal of LSMs, this will depend largely on when ROM provides the list of those due for the renewal. NCCS office will then follow up by informing those on the list to submit the relevant documents within a month of notification.
- ROM would usually release the results of approved new applications and those for renewal, sometime in the middle of the year.
- Since January 2023, NCCS has received 17 new applications for LSM, and 34 applications for the renewal of existing LSM. The final decision to grant new licences or to renew existing licences rests with ROM.
